TOPSPIN VOLLEYBALL PARTICIPANT AGREEMENT

For the purposes of this Topspin Volleyball Participant Agreement (the "Agreement"), the term "Participant" as used herein shall mean any individual participating in any Topspin Volleyball league. If the Participant is a minor, this Agreement must be acknowledged and signed by the Participant's parent or legal guardian.

All Participants of Topspin Volleyball must agree to abide by the following when participating in any league activities under the COVID-19 Response plan and Return to Sport (RTS) Protocol. By participating in the Topspin Volleyball league, the Participant agrees:

- to provide proof of vaccination (digital or paper copy) and government issued ID as required by Provincial Health Order prior to participating in any Topspin Volleyball league play or event.
- to perform symptom screening checks prior to playing in any league play or event, and will let Topspin Volleyball know if the Participant has experienced any of the COVID-19 symptoms in the last 14 days.
- to stay home if feeling sick, and remain home for 14 days if experiencing COVID-19 symptoms.
- to abide by all Topspin Volleyball COVID-19 policies and guidelines.
- RECOMMENDED: to sanitize my hands upon arriving and leaving the league, with soap or sanitizer.
- **RECOMMENDED:** to continue to follow social distancing protocols of staying at least 2m away from others.

The Participant acknowledges that there are risks associated with participating in Topspin Volleyball league activities, and that the measures taken by Topspin Volleyball and the Participants, including those set out above and under the COVID-19 Response Plan and Return to Sport Protocols, will not entirely eliminate those risks. I understand that if I do not abide by the aforementioned policies/guidelines, that I may be asked to leave the league for up to 14 days to help protect myself and others around me. I further acknowledge that continued abuse of the Topspin Volleyball policies and/or guidelines, or any physical or verbal abuse towards any Topspin Volleyball organizer may result in suspension of my participation at the sole discretion of Topspin Volleyball.

AS A CONDITION OF PLAYING IN ANY TOPSPIN VOLLEYBALL ORGANIZED LEAGUE, EACH PARTICIPANT ASSUMES ALL RISK OF PERSONAL INJURY, INFECTION, OR PROPERTY LOSS RESULTING FROM ANY CAUSE WHATSOEVER INCLUDING BUT NOT LIMITED TO PLAYING THE SPORT OF VOLLEYBALL OR PARTICIPATING IN ANY SPORTING EVENT OR LEAGUE HELD BY TOPSPIN VOLLEYBALL ASSOCIATION. EACH PARTICIPANT AGREES THAT TOPSPIN VOLLEYBALL ASSOCIATION SHALL NOT BE HELD LIABLE FOR ANY SUCH PERSONAL INJURY, INFECTION INCLUDING WITHOUT LIMITATION COVID-19, OR PROPERTY LOSS AND RELEASES TOPSPIN VOLLEYBALL ASSOCIATION AND ITS DIRECTORS, REPRESENTATIVES, AND SPONSORS FROM AND AGAINST ANY AND ALL CLAIMS THAT HE/SHE MAY HAVE AGAINST TOPSPIN VOLLEYBALL ASSOCIATION. BY PARTICIPATING IN ANY TOPSPIN VOLLEYBALL LEAGUE OR EVENT, THE PARTICIPANT HEREBY AGREES TO THE TERMS AND CONDITIONS OF THIS PARTICIPATION AGREEMENT.
